If requesting a reduction in patron numbers, you may be required to provide one of the following documents:

- Copy of the planning permit Certificate of occupancy (if applicable)
- Calculation of the patron capacity from a registered building surveyor (based on a ratio of one patron per 0.75 square metres for the area available to the public).

The Commission may request an applicant to provide any other information. If required to do so you will be notified in writing.

If the requested reductions in trading hours or patron numbers are approved, the conditions on your licence will be amended and an updated copy of your licence will be sent to you.

Please lodge this form by **31 December** if you wish to have the reduction in trading hours or patron numbers applied to the calculation of the following year's renewal fees. You will receive a replacement renewal notice for the new renewal fee amount if your request is approved.

Note: If you wish to increase your hours or patron numbers, or change your category of licence you need to submit a 'Variation to an existing licence or permit' application. Application forms can be downloaded from vcglr.vic.gov.au.
